





Environmental Management Policy

The Amsterdam data center campus is purpose-built and precisely located to provide secure colocation facilities for our customers. They offer more than 5,780 m2 of facility space and 2,920 m2 of raised floors for tenant racks.

EdgeConneX wishes to present an image of and behave as an organization that always strives for quality, continuity, durability, superior environmental performance, and delivery of the highest services to our customers and stakeholders. To realize this, EdgeConneX has set up an environmental management system, hereafter called 'management system' which secures all crucial moments in the field of environment. Moreover, this management system fulfils the requirements of NEN-EN-ISO 14001 so that the effect of this management system can also be verified and confirmed by independent parties.

The scope of the management system includes all operating assets, employees (incl. temporary staff), and activities carried out at our Amsterdam Data Center Campus. The scope of the management is defined as follows: "Providing space, power & connectivity to our customers around the world".

An important aspect of the management system is that improvements are continuously and systematically strived for in the area environment. The organization ensures the protection of the environment, including the prevention of pollution. Negative effects on the environment are minimized, so that the quality of the natural environment and the working environment can be positively influenced for both the benefit of the environment and employees.

When determining the scope of environmental issues, EdgeConneX assesses the entire lifecycle – evaluating the organization, and all existing and upcoming operations, to ensure they we meet all applicable laws and regulations.

Further, EdgeConneX ensures a controlled work environment by means of implementing the Risk Assessment, which includes its associated current plan.



The necessary improvements can be initiated in response to the periodic assessments of risk analysis and assessment of the company's continuity, evaluations with customers, internal and external consultations, periodic internal audits, actions based on monitoring and measurement, and an annual management review considering changes to local legislation.

The analysis of risks is a relevant part of the management system, and environmental risks are determined primarily based energy use. To control and mitigate environmental risks, several measures have been implemented and are continually assessed and improved.

Members of the Compliance and Operations Departments make up the ISO 14001 management team, and are responsible for the design, implementation, and evaluation of the environmental management system. The organization is committed to an effective management system that is suitable and appropriate for the organization.

At least once per year, the environmental management system is reviewed, and objectives are defined to achieve appropriate environmental targets. These objectives are developed, monitored, and adjusted where necessary. In addition, the Operations Department takes all possible measures, including making available resources, to implement the policy and to ensure that this policy is understood by all employees, endorsed, and disseminated.

All in-scope employees are responsible for being compliant with the agreements recorded in the management system. The operational management of the management system is carried out by the Operations Department. The environmental management team is responsible for the maintenance of the management system, the implementation of internal audits and for reporting to Executive Management as needed. This policy will be actively promoted to in-scope employees and applied across the organization as needed.
